## RE: Notice of Mail-In Voting in lieu of Annual General Meeting (AGM)

Prior to 2020, we have held our annual general meeting of the Glacier Springs Property Owners Association in person on a Saturday in October. Unfortunately, with the continued risks associated with public gatherings and the Governor's orders, coupled with the inability of non-US-based members to attend, this is again not possible for our 2021 Annual General Meeting.

As in 2020, after consulting with our legal counsel, your Board of Directors has passed a measure that allows us to utilize **mail-in voting** for our business this year. We again feel this is the best measure we can take to ensure our members are afforded the opportunity to participate in Association business without risking health consequences and violating emergency statutes.

At the bottom of this letter, you'll find the main points of business for this year's Annual General Meeting. Please take time to review this information.

## ACTION REQUIRED: Please complete and return your ballot or proxy form by October 31, 2021

Enclosed you will find a combination **proxy form** and **mail-in ballot**. You may either submit your ballot <u>or</u> appoint a proxy to vote on your behalf. Please complete and return this page by post or by email.

If you choose to complete and **submit your ballot**:

- Kindly ensure you have completed all required fields.
- Ballots returned after the due date or missing information in required fields will be null and void.

## If you instead choose to **appoint a proxy**:

- Kindly ensure you have completed all required fields.
- If you submit a General Proxy, your vote will be cast in alignment with the majority of voting members.
- If you submit a named Individual Proxy, your proxy will need to complete and return the ballot form on your behalf by October 31<sup>st</sup>, 2021.
- Failure to secure a minimum of 50 votes by October 31<sup>st</sup> will cost the Association considerable expense to hold a secondary mail-in election.

The Annual Report, Year-End Financial Statements, and proposed FY 2021-2022 budget will be posted at <u>https://glaciersprings.org/news/</u> on or before Saturday, October 2, 2021. I believe you'll find the organization to be in a healthy financial situation with no major operational challenges facing it.
